**CIVIL AVIATION ACT 1969  
CIVIL AVIATION REGULATIONS 1996  
(LICENSING OF AIR SERVICES)**

Pursuant to Regulation 10, ( MALAYSIA CIVIL AVIATION REGULATION, 1996 )  
the Director General of Civil Aviation, hereby grants a licence to XXXXXXXXXXXXXXXX  
( hereinafter referred to as XXXXXXXXXXX ) whose address is at:-

Subject to the conditions specified in PART A, PART B and PART C of this licence.

**PART A**

**ARTICLE 1**

- (1) XXXXXXXX is permitted to operate Schedule Air Services for the carriage of passenger over approved domestic and international routes.
- (2) XXXXXXXX may, on the international approved routes, operate in order as long as the point of origin is a point in Malaysia.
- (3) In respect of the route specified in paragraph (1) above, XXXXXXXX is permitted to exercise traffic rights in accordance with the terms and conditions specified in the current Memorandum of Understanding to the Air Transport Agreements concluded between the Government of Malaysia and the respective Governments.

- (4) In respect of Scheduled Air Services as specified in paragraph (1), the types of aircraft to be used are as follows:-

## **ARTICLE 11**

- (1) The frequency and the Schedule of Services to be operated by XXXXXXXX shall be submitted to the Director General of Civil Aviation for approval.
- (2) XXXXXXXX may commence operations on the routes specified in ARTICLE 1, above, after the Schedule of Services has been approved by the Director General of Civil Aviation .

## **PART B**

### **ARTICLE 111**

- (1) This licence is valid for a period not exceeding five (5) years with effect from XXXXXXXXXXXX without prejudice to the powers of the Director General of Civil Aviation to revoke or suspend this licence in accordance with the relevant laws in force in Malaysia.
- (2) Without prejudice to sub-paragraph (1) of this Article, this licence is granted subject to the condition that it may be terminated by the Director General of Civil Aviation on giving XXXXXXXX three (3) months notice in writing. The period of the three months, as aforesaid, commences from the date such notice is given.
- (3) The Director General of Civil Aviation may add, vary, revoke any of the term and condition when deemed necessary to do so.

## **PART C**

**ARTICLE 1V**

- (1) The holder of this licence shall comply with all regulations, rules and instructions in force pertaining to civil flights in Malaysia.
