 - 1.1 In exercise of the powers conferred by regulations 60A and 202 of the Civil Aviation Regulations 2016, the Director General makes this Flight Operations Notice ("FON").
 - 1.2 This FON is published by the Director General under section 24o of the Civil Aviation Act 1969 [Act 3].
2. The list of Medical Examiner

The lists of medical examiners as approved by the Director General –

 - (a) to issue, revalidate and renew Class 1, Class 2 and Class 3 medical certificates in Peninsular Malaysia are as specified in the First Schedule;
 - (b) to issue, revalidate and renew Class 1, Class 2 and Class 3 medical certificates in East Malaysia are as specified in the Second Schedule;
 - (c) to revalidate and renew Class 1, Class 2 and Class 3 medical certificates in Peninsular Malaysia and East Malaysia are as specified in the Third Schedule;
 - (d) to act as an ophthalmologist are as specified in the Forth Schedule; and
 - (e) to issue, revalidate and renew Class 1, Class 2 and Class 3 medical certificates in Singapore are as specified in the Fifth Schedule.
