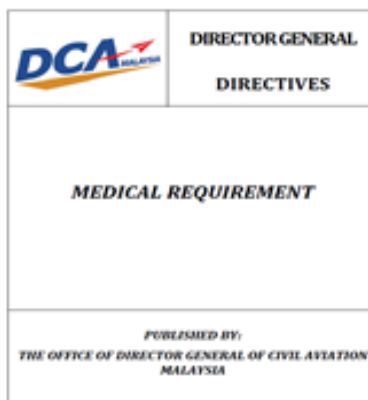

## Class 3 Medical Assessment For Air Traffic Controllers

02 May 2017

A Class 3 Medical Certificate is required for the applicant and renewal of an Air Traffic Controller Licence in accordance with *Regulation 153 Air Navigation Services Regulatory Manual of MCAR 2016*.
